- 2. A copy of the solid waste account holder's driver's license or picture identification.
- 3. <u>Three</u> consecutive months of each household member's checking and/or savings account statement.
- 4. The original notarized 2024 Washington County Solid Waste Exemption Affidavit and Application.
- 5. Completed Washington County Solid Waste Questionnaire.

All completed applications along with all accompanying documentation must be submitted in original form to the Washington County Solid Waste Disposal Authority located at 25 Court Street, Chatom, Alabama or by mail to the following address:
